**4. Trustees' Report Simon** thanked the Treasurer in her absence for putting together the Annual Report. Metal Detecting Day had raised over £3,000, and the Company of Friends generous donation from the profits of the variety show were gratefully received. The trustees all agreed the Trustees' Report, and voted unanimously to require Claire and Simon sign and send to the Charity Commission.

### 5. Financial Report

Dick Middleton presented the end of year annual report, which had been circulated to the Friends.

## Summary for the 12 months to end of March 2013

The balance in the accounts stood at £10,431 at the end of March, of which £1,365 is in the current account, £9,000 in the investment account and £66 in petty cash.

The total income for the year was £7,368 with expenditure of £864 and grants of £7,950 leading to a **net outflow of £1,446**.

The metal detecting contributed £3,653 to funds (2011 - £3,212). Donations have been received from the Company of Friends from the proceeds of their Pantomime (£1,400), Pip Wright for his talk to the Lions (£100) and Penny Harris (£25). We have also received £293 from HMRC for Gift Aid tax relief relating to donations in the 2011/12 financial year.

Interest income has risen since the prior year as the balance in the investment account has increased.

We made a grant of £7,950 to Bacton PCC for the repairs to the North aisle window and upper flint wall.
